### 1.0 <u>ROLL CALL/QUORUM</u>

President Steinhauser determined a quorum to be present, convened the meeting at 12:23 p.m. and thereafter presided. Executive Director Marcia Koslov recorded the Minutes.

### 3.0 ACTION ITEMS

- 3.1. Approval of Auditor. As discussed at the January 2007 Board meeting, the Executive Director interviewed three of the six audit firms that submitted bid proposals. The Executive Director recommended that the Law Library negotiate a contract for audit services with Vasquez and Company. Trustee Bryant-Deason recused herself from the discussion and the vote. A motion was made by Trustee Wiley and seconded by Trustee Pluim to approve the bid proposal of Vasquez and Company (Vasquez) for audit services for the Law Library for fiscal years 2004-05 and 2005-06 and authorized the Executive Director to negotiate and execute a contract for such services subject to the Executive Director's first contacting Vasquez to confirm that they will not be working with KPMG at any time during the term of the contract, that they are not owed by KPMG, and that KPMG does not have any ownership interest in Vasquez nor does Vasquez have any ownership interest in KPMG. The motion was approved, 4-0, with Trustees Klein, Pluim, Wiley and Steinhauser voting in favor of the motion.
- 3.2 Approval of Elevator Upgrade. Following discussion, the Board of Trustees directed the Executive Director to investigate whether or not there are other companies who might provide additional proposal for the upgrade work. In addition, the company should provide warranty information for any work completed.
